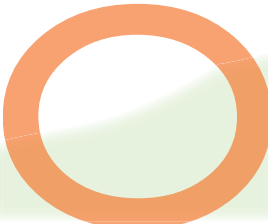
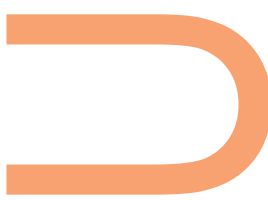
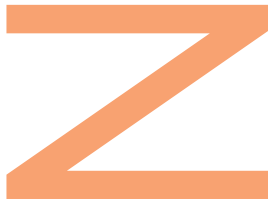

PERMANENT PARKING PASSES FOR HUDSON RESIDENTS:

USE OF LOUD EQUIPMENT

A reminder that construction work or the use of loud equipment such as chainsaws can be carried out during the following hours:

Fines for a first infraction range from \$200 to \$1,000 per day for an individual, and from \$400 to \$2,000 per day if the offender is a business. For each repeat infraction, fines range from \$400 to \$2,000 per day for an individual, and from \$800 to \$4,000 per day if the offender is a business.

ENVIRONMENT

THIS SUMMER I AM SECURING MY POOL!

Beginning in May 2024, Urban Planning inspectors will conduct inspections of the residential pools in the Municipality. This exercise aims to help pool owners identify any non-compliance with their installations before the September 30, 2025 deadline.

In May 2021, the Quebec government announced new rules regarding pool safety, which have been in effect since July 1, 2021. The purpose of these new rules is to render even safer the structures surrounding any residential swimming pools (in-ground, above-ground, semi-in-ground, removable). The new rules aim to control the access of occupants to the pool by simple measures such as the installation of an enclosure equipped with a security door.

These rules now apply to all pools, regardless of their installation date. Homeowners have until September 30, 2025, to bring their installation into compliance. Therefore, it is important that residents affected by these new rules become aware of the changes to ensure compliance. RAGWEED: RECOGNIZE IT, ELIMINATE IT

Every summer, ragweed causes much discomfort for those allergic to its pollen, such as throat tingling, repeated sneezing, and several other symptoms. That's why it's important to pull it out now to minimize the impact of its pollen, which is responsible for hay fever.

Ragweed is not the same plant as poison ivy. Although these plants have similar names in French (l'herbe à poux and l'herbe à puce), they are quite different. While poison ivy causes painful skin inflammation upon contact with the sap, ragweed, on the other hand, is harmless. It is therefore possible to easily get rid of it in various ways.

- Pull the plants out and dispose of them in the trash (never in compost);
- Mow the lawn regularly to prevent the plant from flowering;
- Sow grass seed on bare soil;
- Use mulch or ground cover plants in areas where there is no lawn.

LAWN WATERING

By-law 723 governs the use of drinking water produced by the municipal water system. Lawn watering is restricted based on address and type of watering system. If you have:

- An automatic watering system, you are permitted to water your lawn only from 2 a.m. and 4 a.m., on the day corresponding to your address (see table below).
- A mechanical watering system, you are permitted to water your lawn only from 8 p.m. and 10 p.m., on the day corresponding to your address (see table below).

USE OF PESTICIDES

If you are considering spraying pesticides on your land, note that By-law 739 on the control of pesticides prohibits their use throughout the territory except for certain exceptions such as cases of infestation, security, public health, or prevention reasons. Anyone wishing to use pesticides on their land must apply for a permit and ensure that the conditions outlined in By-law 739 are met, otherwise they are liable to penalties. PROPERTY INSPECTION VISITS

Inspection visits for the purposes of the property assessment roll are currently underway.

- The property assessment firm, Les Estimateurs Professionnels Leroux, Beaudry, Picard & Associés will be conducting the visits. The firm's representatives will carry a photo ID and an identification letter signed by an authorized Town representative.
- The owner or occupier has an obligation to allow the inspector access to the property.
- The information collected will be included in the property file; a fundamental aspect of preparing and maintaining the property assessment roll.

SPOTLIGHTING ORGANISATIONS IN OUR VIBRANT COMMUNITY:

The War Memorial Library

Celebrating its 75th anniversary, the War Memorial Library is a non-profit registered charity deeply woven in the fabric of Hudson for over seven decades. The library provides a subscription service of printed materials as well as CD audiobooks and DVDs, primarily in the English language, extending its services to the residents of Hudson and surrounding communities.

Every Saturday, from 9 AM to 12 PM, the library operates a thrift store known as the Bunker, selling donated items at very reasonable prices, with 100% of the proceeds directly supporting the library and other charities. Notably, the Bunker has been located in the library basement for over 75 years.

Run by a group of dedicated volunteers, the War Memorial Library & Bunker sustains itself through membership fees, donations, and fundraising activities. Beyond meeting its own needs, the library, with money raised through the Bunker, consistently donates to many other charities. To date, the library has given back in excess of \$700,000 to our local community!

The existing building, originally constructed for the Masons in 1923, currently houses the War Memorial Library and Bunker. Post-World War II, the library relocated to this building with a specific focus on serving as a War Memorial, honouring those in Hudson who served in the Canadian Armed Forces.

WASTE MANAGEMENT

Waste comprises all the materials generated by households and businesses: garbage, bulky items, recycling and organics, such as food and yard waste.

Did you know?

The Politique Québécoise de gestion des matières résiduelles aims to eliminate waste in our society. One of its objectives is to ban organic materials from landfill because they can be composted and recovered.

Organics

Participating in the organics collection helps to reduce greenhouse gases (GHG) released from landfills. When organics are sent to landfills, they decompose very slowly due to the absence of oxygen in a process that releases methane, a very powerful GHG. Organics collected by the Town are sent to the composting site in Lachute where they are quickly transformed into compost and returned to residents.

Did you know?

Complexe Enviro Connexions, the most important landfill in the Communauté Métropolitaine de Montréal (CMM) and where Hudson's garbage is sent, is slated to reach its maximum capacity in 2027! A request to increase its size and capacity has been submitted to the government.

Interesting Hudson statistics

In 2021, according to the ministère de l'Environnement, de la Lutte contre les changements climatiques, de la Faune et des Parcs, the Town of Hudson produced 3521 tons of garbage. This represents 633 kg per resident. When we add recycled and composted waste, we can calculate that only 8 % of the total waste produced on Hudson's territory was composted, 14 % was recycled and 77 % was sent to landfill.

It is interesting to note that 50 % of the total waste produced came from the construction, renovation and demolition (CRD) sector and only 24 % was household garbage. CRD waste can be better managed by taking it to the Ecocentres.

Ecocentres

Ecocentres are recycling facilities. They accept dangerous residues, electronics and CRD waste. They can also take and safely recycle home appliances including refrigerators and air conditioners which contain halocarbons, extremely potent GHGs. Two Ecocentres are located near Hudson; one in Rigaud, the other in Vaudreuil.

PESTICIDE USE

Avant-garde and proactive, the Town of Hudson was the first town to ban the cosmetic use of pesticides. In 1991, the Town adopted a by-law without precedence and defended it in the Supreme Court of Canada in 2001. A historical favourable judgment encourages other Quebec towns to legislate pesticide use.

In 2021, the pesticide by-law was updated. By-law 739-2021 prohibits the use and application of pesticides outside of buildings within all of Hudson. Pesticides are insecticides, herbicides, fungicides and rodenticides.

Some exceptions can be found in the by-law. For example, low impact pesticides are allowed provided they are used in accordance with the product label. Low impact pesticides include borax which is used to eliminate ants.

The use of neonicotinoid pesticides, which according to Health Canada pose a threat to bees and aquatic life, is strictly prohibited.

Also, pesticide use in sensitive zones such as schools, daycares, clinics and private residences for the elderly are always prohibited.

Did you know?

A product sold in stores is not necessarily authorized. For example, the use of glyphosate, commercially known as Roundup, is not permitted. You must therefore obtain a permit before applying it to your property.

In the case of an infestation, a temporary permit for the application of pesticides can be issued only after all environmentally friendly alternatives have been exhausted.

Did you know?

Golf courses and agricultural land are subjected to special clauses. Both must submit an annual report describing all pesticide applications. In addition, golf courses must obtain the ACSP for golf certification issued by Audubon International which ensures the sustainable management of the golf course.

All commercial applications of pesticides and fertilizers must be carried out by a town-registered company. The employees must use a vehicle clearly identified with the name of the company. You can help the Town ensure that all lawn care companies are registered by reporting the presence of a truck in your neighbourhood.

Although pesticides can be useful when trying to reduce nuisance organisms, it should be considered that such chemicals also destroy beneficial organisms. Insecticides are harmful to insects such as monarch butterflies and bees. Insects are essential for ecosystem balance. They are food sources for birds and small mammals. Herbicides destroy native plants that produce nectar, essential to pollinators. Avoiding pesticide use therefore helps protect biodiversity. Green spaces can be managed ecologically using alternative methods. These will be shared with you in upcoming editions. Stay tuned!
